- Taxes Not updated since 2015. We do not have our 501c6 as we previously thought. The documents were completed on our end, but the paperwork has gotten lost between the accountant and the IRS. Kristin will be speaking to the accountant.
- LARA current with our licensing and documents.
- Sponsorships We have new levels of sponsorships and two Platinum already. Restoration 911 is Holiday Party, Jacob's Farm will be sponsored by State Savings.
- MAR Past Presidents would like us to attend all national, state and local events. MAR has never been considered in our budget. We have money is our educational budget.
